FIRE DRILL FREQUENCY: There shall be at least two fire exit drills during the first two weeks of a school term and six additional fire exit drills per year. In climates where weather is severe during the winter months, at least five drills shall be held at the beginning of the school term and three drills after the winter months to complete the eight required fire drills.

TORNADO DRILL FREQUENCY: Two tornado drills are required; it is recommended to execute each drill in the Fall and Spring.

LOCK-DOWN DRILL FREQUENCY: 3 lock-down drills are required; it is recommended to execute each drill in the Fall and Spring.

FIRE DRILL RECORDS: A record of all fire exit drills shall be kept on the premises and persons responsible for such occupancies shall file written reports with the code official not less than twice a year. Each report shall contain the following information (see above chart as "report"):

1. Time of day the drill was conducted
2. Date the drill was conducted
3. Weather conditions at the time of evacuation
4. Number of occupants evacuated
5. Total time for evacuation
6. Other information relevant to the drill

Emergency Lighting tests should occur after the afternoon dismissal each month. Initial and date, in appropriate space.

Fire Alarm tests should occur after the afternoon dismissal each month. Initial and date, in appropriate space.
